The Director Finance was of opinion that quoted Rate in the financial Bid opened on 20-09-2024 were remain same, only the GST percentage was changed as per circular issued by Federal Board of Revenue vide letter No. 1/8-STB/2024 dated 05-08-2024, in the meeting of tender / purchase committee held on 25-09-2024. Furthermore the rates of M/S MCL, remain lowest after re-calculation of GST percentage. The committee rejected the presentation of M/S Medigas, Lahore.


